NOTICE

Sub: Filling of college preferences by candidates figuring in the Final Common Merit List for Need-Based Academic Arrangement Faculty for the Academic Session 2026-27.

The Final Subject-wise Common Merit List for engagement as Lecturer / Teaching Assistant / PTI / Librarian on need-based Academic Arrangement basis for the session 2026-27 has been published on the Academic Arrangement Portal on 30-07-2026.

The window for filling college preferences shall open on 30th July 2026 at 4:00 PM and close on 1st August 2026 at 4:00 PM. Candidates may access the preference form through their existing candidate login at <https://jkaa.directorcollegesjk.in/>, where the tentative subject-wise vacancy position is also available for their guidance.

Candidates are advised to note the following carefully before entering their choices.

Allotment shall be made strictly on the basis of merit and the order of preference recorded by the candidate. There is no facility for upgradation after allotment.

A candidate may enter any number of preferences, but should enter only those colleges where he or she is genuinely willing to join. Entering a college as a preference will be treated as willingness to serve there. Candidates are therefore cautioned against selecting those colleges where they do not wish to join.

Preferences remain editable until the closing time. Whatever preference order stands recorded at the closing time shall be treated as final irrespective of submission.

A candidate who is not allotted any college in a round for want of an available vacancy as per merit shall automatically remain in the reckoning for the subsequent rounds; no fresh action on his or her part is required.

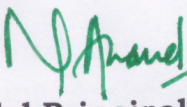
Subsequent rounds of allotment, if any, shall be held only against vacancies remaining unfilled on account of non-reporting, resignation or change in

requirement. A candidate once allotted in any round shall not be considered for re-allotment in a subsequent round.

If a candidate fails to report at the college allotted to him or her, the allotment/selection shall be deemed to have been cancelled, and such candidate shall not be considered in any subsequent round, nor shall any upgradation be available.

Change of college after allotment shall not be permitted under any circumstances.

Candidates are accordingly advised to fill their preferences thoughtfully and with due regard to the distance and accessibility of the colleges opted for, as no request for change of allotted college shall be entertained.
